GENERAL INSTRUCTION AND GUIDELINES FOR ADMISSION OF I.V. G.P. RATING COURSE

(A) REQUIRED DOCUMENTS AND FEE -

1. EDUCATIONAL QUALIFICATIONS

- > Pass in 10th Examination from a recognized Board/University.

2. MEDICAL FITNESS REPORT/CERTIFICATE

- > Medically Fitness Certificate from Institute approved or DGS approved Doctor.
- > Eye sight should be 6/6 without glasses and no color blindness.

3. CASTE CERTIFICATE FOR SC/ST/OBC/EWS

- > The benefit of caste based reservation will be given only to those candidates who have produced the category certificate issued by the competent authority.

4. FEE DETAILS

- > Total fee Rs. 35200/- (Rupees Thirty Five Thousand Two Hundred) only must be paid at the time of admission for I.V. G.P. Rating Course. Fee Break Up are as under:

- > 10 passport size color photographs.
- > ID Proof & Address Proof.
- > Caste/ categorization certificate for reservation if required.
- > Medical fitness certificate and eye sight test certificate.
- > Demand Draft/ payment proof.

Note: Please bring all certificates in original in support of educational qualification, age proof, Id proof, address proof, caste /categorization certificate along with one set of photocopies of the same at the time of admission.

(B) LEGAL DOCUMENTATION -

- > Candidates will be required to execute an agreement: undertaking & indemnity on non judicial stamp paper. The Institute may facilitate this for you.
- > Legal documents to be executed by parent/legal guardian or by the candidate himself.

(C) PARENTS/GUARDIANS VISIT TO THE CAMPUS -

- > In order to prepare the trainees for profession, parents/guardians/ friends are **not allowed** on the campus during training period. In case of an emergency, parents can contact the Duty Officer/Instructor on 24 X 7 hour Duty.

(D) ITEMS TO BE BROUGHT BY THE CANDIDATE -

- > The candidate has to bring the following items at his own cost prior training/course for their personal uses.

(H) MEDICAL, VACCINATION, VISITING DOCTOR AND MEDICATION -

- > Medication for minor common ailments is provided at the campus.
- > Costs of any visits to doctors or visit to specialist or hospitalization are to be borne by the candidate.
- > All medicines prescribed by the Doctor shall be bought by the candidate at his own cost.
- > However in house doctor visits the campus once a week or as when required, which is free of cost.

In view of high Hospitalization costs, it is **recommended** that each candidate has a medical insurance cover of minimum Rs. 1,00,000/- Medical Insurance may be obtained by the parents at their own cost from any Insurance Company.

(I) INSTRUCTION -
